## Advancing Macomb Board Members Collaborate to Fund Mt. Clemens Riverfront Development

The Advancing Macomb board answered a call to help provide gap funding for the new recreation and launch site on the Clinton River in Mt. Clemens. Final bids for the project came in much higher than anticipated due to additional engineering needed to lower ongoing maintenance costs. The Clinton River Watershed Council spearheaded the project as a part of its broader Watertowns® initiative.

"The joint leadership of Henry Ford Macomb, McLaren Macomb and Lipari Foods made sure this project got off the ground," said Melissa Roy, Executive Director of Advancing Macomb.

The funding together with the Clinton River Watershed Council's additional funding will bring new paddling opportunities and a whole range of enjoyment on the waterfront in 2018.

The initial funding campaign in January generated so much interest from residents and local organizations, that the Clinton River Watershed Council could secure an additional \$50,000 from the Michigan Economic Development's Placemaking Match-grant program.
